Direct Recruitment of Sports Personnel against Sports Quota

Food Corporation of India (hereinafter termed "Corporation"), one of the largest Central Public Sector Undertakings, dealing in Food Management and Allied activities wishes to recruit 4(four) meritorious sports personnel as **Assistant Grade III (General)** in IDA Pay Scale of Rs.9,300 – 22,940/-. Applications are invited from Indian Nationals fulfilling the prescribed qualification, experience, age, etc. for the disciplines indicated below :

2. **Age Limit:** Between **18-25 years** as on 01/07/2010.

3. **Age Relaxation:** i) Relaxation by 5 years for SC/ST candidates and 3 years for OBC candidate (ii) Age is further relaxable by 5 years for departmental candidates, if otherwise eligible (maximum 10 years in case of departmental SC/ST candidates and 8 years in case of departmental OBC candidates). (iii) Age is also relaxable by 5 years who had ordinarily been domiciled in the Kashmir Division in the State of Jammu & Kashmir during the period 01/01/80 to 31/12/89. Any person intending to avail the relaxation of age limit under this category shall submit a certificate from (a) the District Magistrate in the Kashmir Division within whose Jurisdiction he had resided; or (b) any other authority designated in this behalf by the Govt. of Jammu & Kashmir to the effect that he had ordinarily been domiciled in the Kashmir Division in the State of Jammu & Kashmir during the period from 01/01/80 to 31/12/89.

4. Educational Qualification: Graduation in any discipline from any recognized University.

5. Eligibility: In any of the above disciplines, the person should, in the year immediately preceding his application for recruitment in the Corporation, have represented :

- (i) A University in the Inter University Tournament conducted by the Inter University Sports Board; and / or
- (ii) A combined University team in the National and World Universiad International competition; and / or
- (iii) A State in the National competition ; and / or
- (iv) The country in any International competition .

Note : (a) Players who have represented the country in the Indian National Team or in the combined university team in the international events shall be given preference.

(b) The Certificate for representing a University in the Inter-University or a State in India in a National or for representing India in an International competition in one of the recognized Games / Sports will be valid only when signed personally by the Dean/Director or the officer overall in-charge of sports in the university or the Secretary of the State Association or the Secretary, National Federation/National Association respectively.

6. General Condition:

- a) Employees of the Central/State Govt./Public Enterprises should forward their applications **through proper channel** to reach the Corporation before the last date notified below. Direct applications shall not be entertained.
- b) The Corporation may, at its discretion, relax qualification and age in appropriate cases in accordance with the rules.
- c) Mere submission of application and fulfilling the eligibility condition would give no right to any person for interview/selection.
- d) All appointments will be subject to the Rules and Regulations of the Corporation and/or directives of Govt. of India, in force from time to time.
- e) The above mentioned posts carry IDA pattern pay scale and usual allowances such as , DA, HRA, etc. Other benefits like CPF, Gratuity, Leave Travel Concessions, Leave Encashment, Medical Reimbursement, Conveyance Reimbursement, Lunch subsidy etc. shall be applicable as per the rules of Corporation as amended from time to time. Gross emoluments would vary depending upon place of posting.

f) Candidates called for interview will be reimbursed Second Class sleeper Railway fare/Bus fare "To & Fro" by the shortest route, subject to production of Railway Tickets / Bus Tickets.

g) The Prescribed qualification, eligibility, age limit etc. shall be reckoned as on 01/07/2010.

7. Self attested photocopies of all documents in respect of proof of age, qualification, Sports achievements experience, caste, etc. should be attached with the application. Original Certificate will be called for and scrutinized at the time of interview.

8. Any attempt to influence the Corporation in any manner would disqualify the candidature.

9. No correspondence will be entertained about the outcome of the application.

10. Candidates should satisfy themselves that they fulfill the required eligibility , qualification, age, etc. before applying for the same.

11 Application not in the prescribed format and/or incomplete applications shall be summarily rejected.

12. **Selection Procedure**:- Applications received upto the prescribed date will be scrutinize by Food Corporation of India. Shortlisted candidates will be called for interview and verification of original documents.

13. **How to Apply :**

i) Application shall be neatly typed /filled in the prescribed format in A-4 Size paper.

ii) Attested copies of all the required documents in support of Age, qualification, sports achievement, caste etc. shall be attached.

iii) Applications complete in all respects & duly signed by the applicant be placed in a sealed envelop.

iv) The envelop shall be super scribed with the words **“APPLICATION FOR THE POST OF ASSTT. GRADE III (GENERAL) UNDER SPORTS QUOTA”**.

vi) The applications should reach at above address by **17/08/2010**. For candidates belonging to **J&K** and NE States, last date for receipt of applications will be **01/09/2010**.

vii) The applications reaching beyond the above mentioned last date will not be accepted.

viii) The Corporation will not be responsible for postal delay or any other reason for the delay.

14. Application fee:Rs.300/- by way of crossed Demand Draft / Bankers Cheque / Pay Order / Indian Postal Order in favour of " **Food Corporation of India, Zonal Office (West)**" payable at **MUMBAI** (No fee for SC/ST candidates).

15. Decision of FCI Authority : The decision of FCI authorities in all matters related to acceptance or rejection of the application, mode of selection etc. will be final and binding on candidates.

16. Selected candidates will be liable to be posted anywhere in West Zone, consisting of State of Maharashtra, Goa, Madhya Pradesh, Chattisgarh & Gujarat.

17. Selected candidates will have to execute a Bond for serving the Corporation for a minimum period of 5 years.

18. The Corporation reserves the right to accept or reject any or all applications, without assigning any reason.
